

# **POST SHOW REPORT**



#### Saigon Exhibition & Convention Center 16 – 18 / 11 / 2022

One of the most essential and reliable ASEAN leading exhibition for footwear and leather industries, **The 22<sup>ND</sup> INTERNATIONAL SHOES & LEATHER - VIETNAM 2022 incorporating INTERNATIONAL FOOTWEAR & LEATHER PRODUCTS EXHIBITION -VIETNAM 2022 (IFLE 2022)** was successfully held at Saigon Exhibition and Convention Center (SECC) on **16-18 November 2022**.





Shoes & Leather - Vietnam 2022 had recorded 301 exhibitors from 21 countries and regions (including: Bangladesh, Brazil, Cambodia, China, France, Germany, Hong Kong, India, Indonesia, Italy, Japan, Malaysia, Russia, Singapore, Spain, Taiwan, Thailand, The Netherlands, Turkiye, United Kingdom and Vietnam) and attracted 8,868 trade visitors from 42 countries and regions engaging in a total area of 8,000 sqm exhibition hall.



**301** exhibitors came from **21** countries and regions



The majority of exhibits are machinery (footwear, sewing, tanning & leather goods) (31%), shoe materials (18%) and leather & tanning (17%).






